MOEX's Challenge

Moscow Exchange (MOEX) is one of the world's top 20 exchanges, and one of the few on-exchange venues for FX trading globally.

Roman Sulzhyk, Managing Director of MOEX, was responsible for this project. Mr. Sulzhyk, who worked previously in New York and London at JP Morgan Chase, and after that at Deutsche Bank, had clear priorities from the outset.

Using the FINCAD platform and working with an Excel® interface, MOEX financial analysts were able to prototype each and every type of OTC trade they wanted to support.

In a relatively short period of time, they were also able to test their models and validate the results.
